Nate's Pass is being provided to you by The Nathan Yip Foundation, a local non-profit organization founded in 2002, by Denver residents Jimmy and Linda Yip, after they tragically lost their only child, Nathan, in an automobile accident. Nathan, 19 years old, was a freshman at Lehigh University in Pennsylvania. Since Nathan's death, the Yips have built a foundation in his name to provide educational access, empowerment and ongoing support to youth throughout the world. Nathan's legacy lives on in the many projects, like Nate's Pass, funded in his name.

A limited number of RTD bus passes will be available on a monthly basis through the Student Assistance Fund office.

The following policy will be strictly followed.

1. Students must have a current school year SAF contract on file in the SAF office-room 130.
2. Student's family must qualify under the RTD income guidelines. Reduced fare bus passes will be sold for \$20 per month in room 130. **CASH ONLY.**
3. **Attendance requirement:** The SAF staff will look at student's attendance each month. If a student has 8 or more PERIODS of unexcused absence in the prior month, the student **WILL NOT BE ELIGIBLE FOR THIS PROGRAM.**
4. Grades may be used as a criteria for bus pass eligibility, an F grade can disqualify you.
5. Bus passes will be distributed to qualified students on a first come first serve basis. We may run out of bus passes.
6. Students will be added to the bus pass eligibility list after all completed forms are returned to the SAF office-room 130.
7. This program is funded by The Nathan Yip Foundation a local nonprofit that seeks to provide educational access, empowerment and ongoing support to vulnerable youth throughout the world, giving them the tools to become productive, contributing citizens within their communities.

A completed application enrolls a student in the SAF reduced rate RTD program. This does not entitle a student to a bus pass as access to this program is earned by good attendance and good grades.
